

blood contains about 30 MG of alcohol then, the police has the right to arrest the person without any warrant.



- According to Code of Criminal Procedure, the citizens are not aware about that while cooking if their gas cylinder blasts then the Gas agency authority is liable to make the payment of rupees 50,00,000 as compensation to victims. The victims should file an FIR on gas cylinder blasts to the police station and submit that to the respected gas agency for claiming the compensation.
- As per the Maximum Retail Price act, the shopkeepers are not allowed to charge more price than the printed price of any product but the customer can bargain the product for lesser price than the printed price.
- According to child labor act in India, a child who is below 14 years of age are not supposed to do work in any factories or organization.
- Untouchability is abolished by the (article 17) and its use in any kind should be punishable. The offender should be punishable up to maximum of 2 years of imprisonment and also he or she will be disqualified forparticipating in election for both union and state legislature.

- For the protection of children below the age of 18 from sexual abuse and exploitation, the Posco Act was passed.

- Those citizensare not aware that a child who is below 14 years of age are not supposed to do work in any industries also they should get basic education according to Right to Education Act, 17% of students responded that basic sanitation is a major problem and 25% of students responded that women's safety is a major problem. The citizens were not aware that what are offences or punishment if they miss behave to women in India
- The researcher gives an information from this study that it is necessary for the students to study basic laws and 60% of students responded that to avoid common problems due to lack of knowledge of basic laws and
